

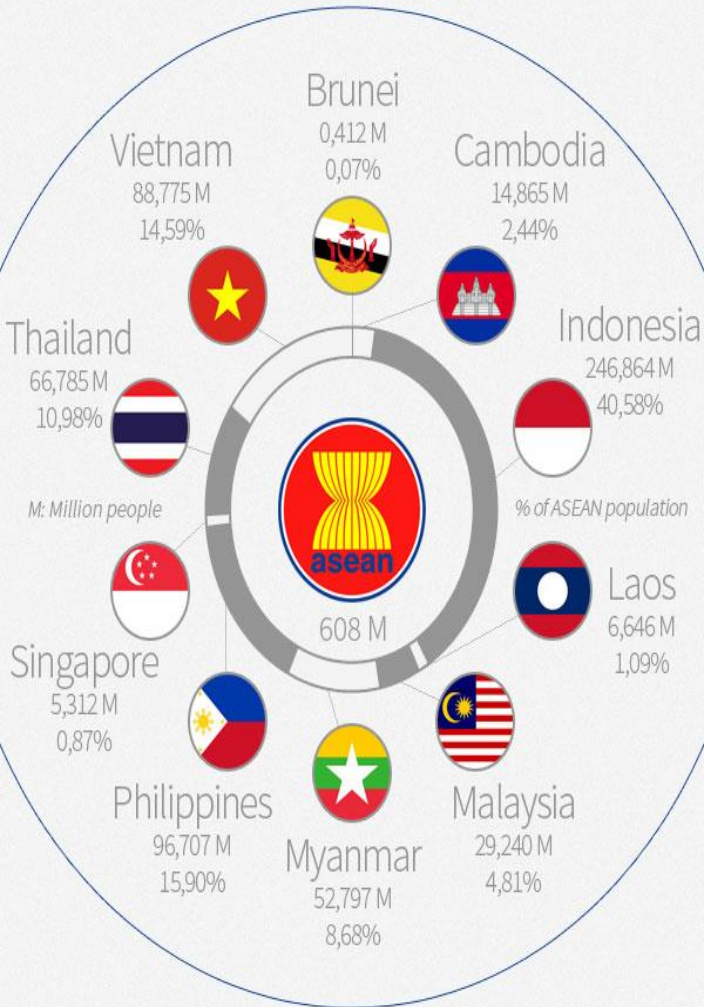

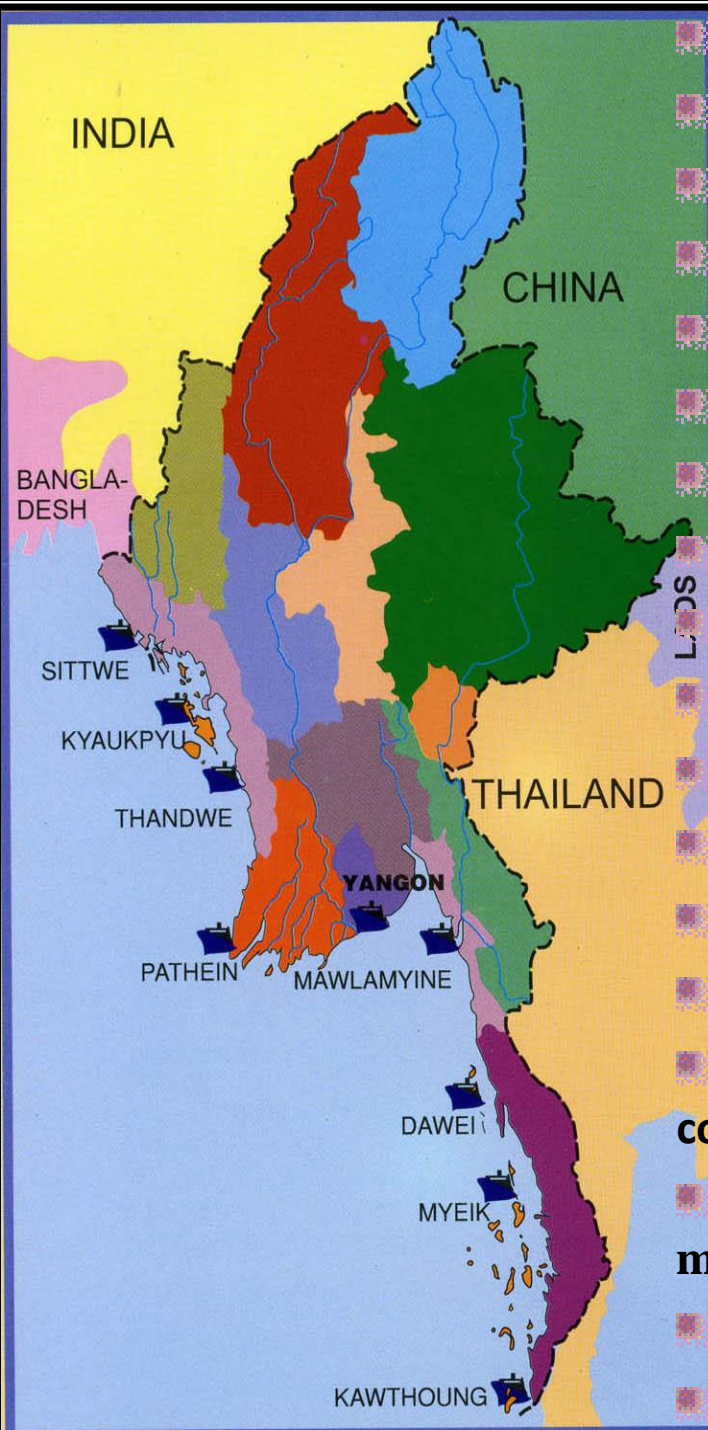
ASEAN POPULATION

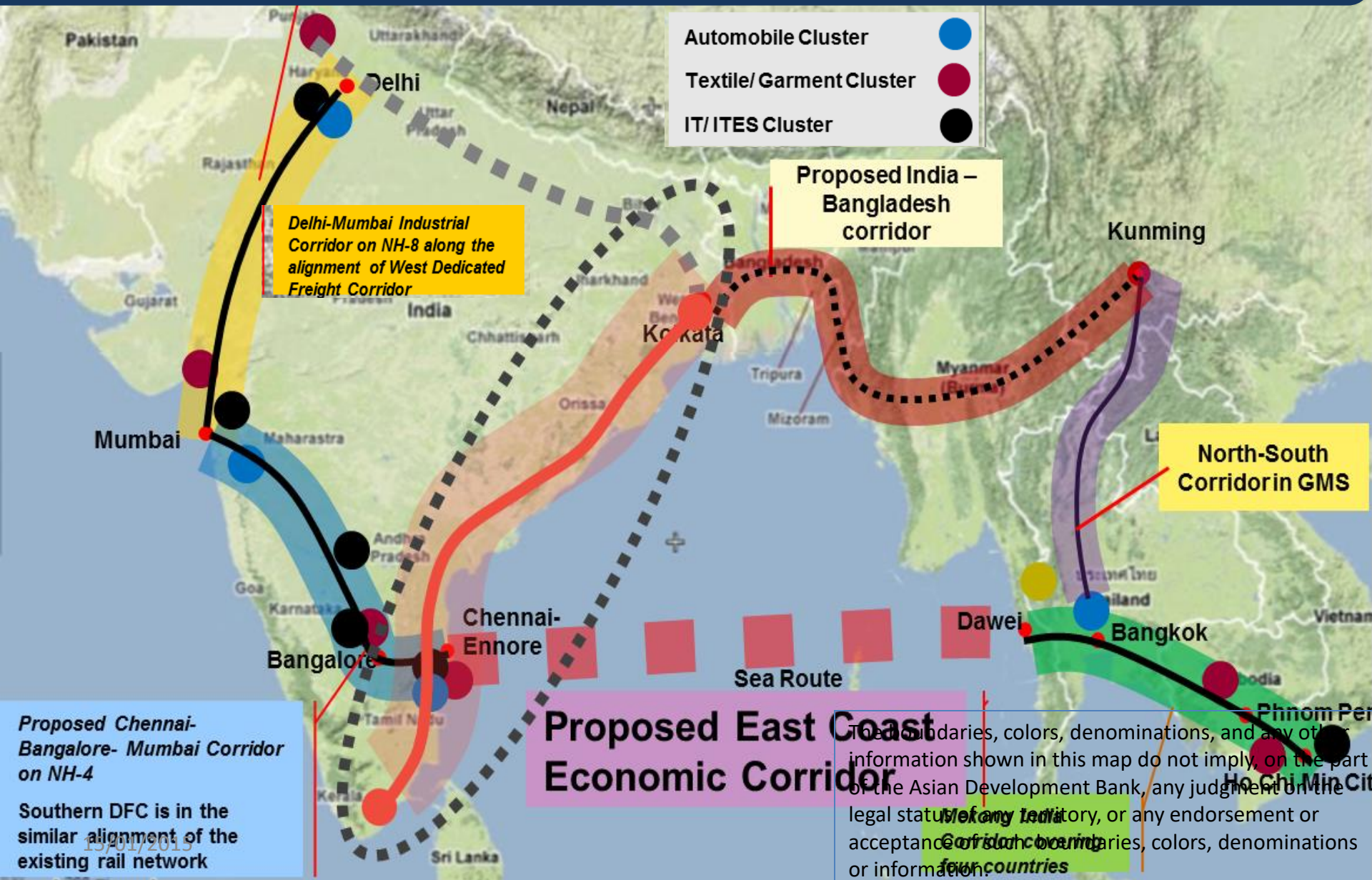

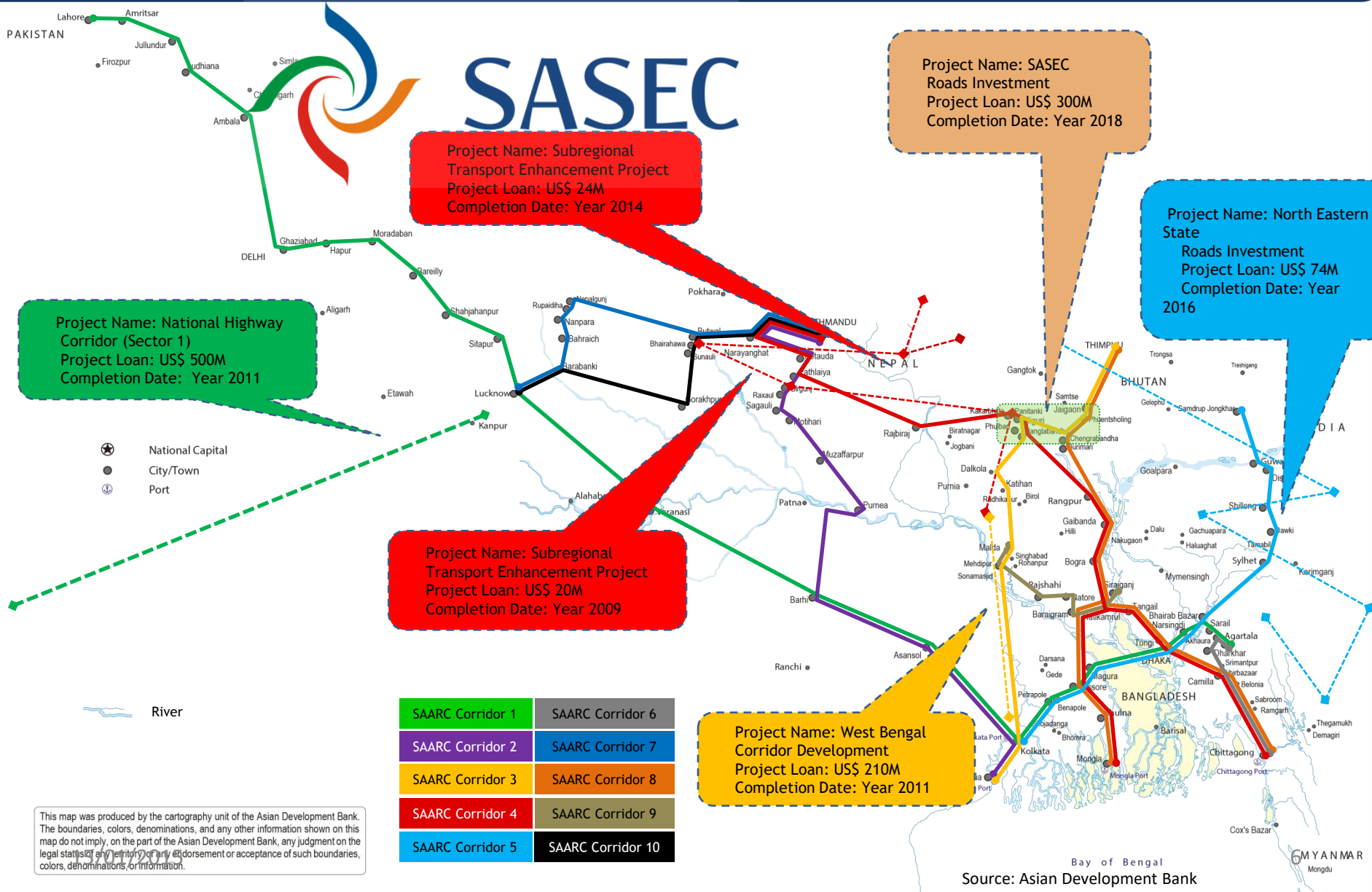

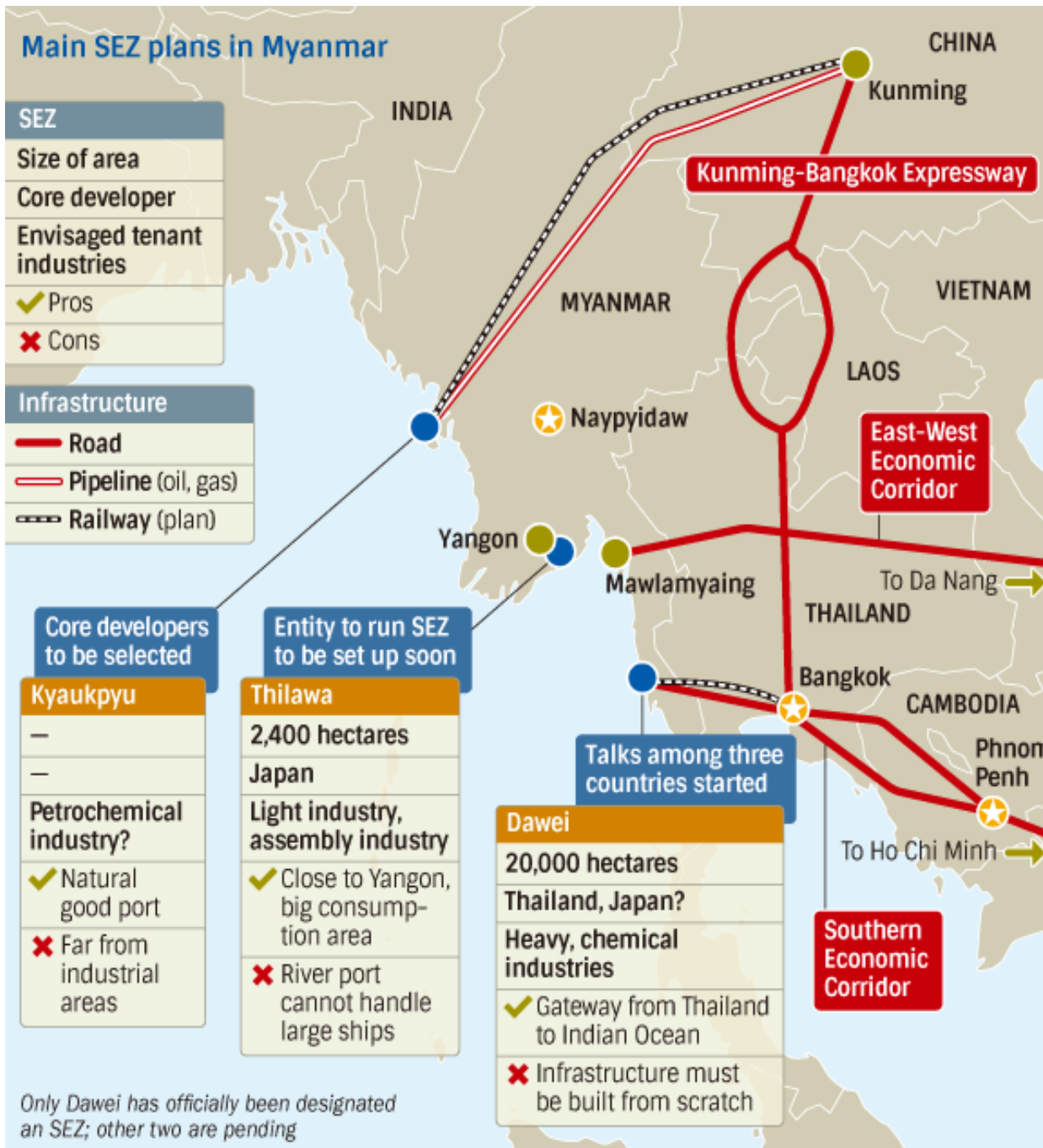

The Dawei deep-sea port project will open up a new transport link for Southeast Asia and southern China. Further down in Satun's Langu district is a Thai plan to build a new port at Pak Bara.

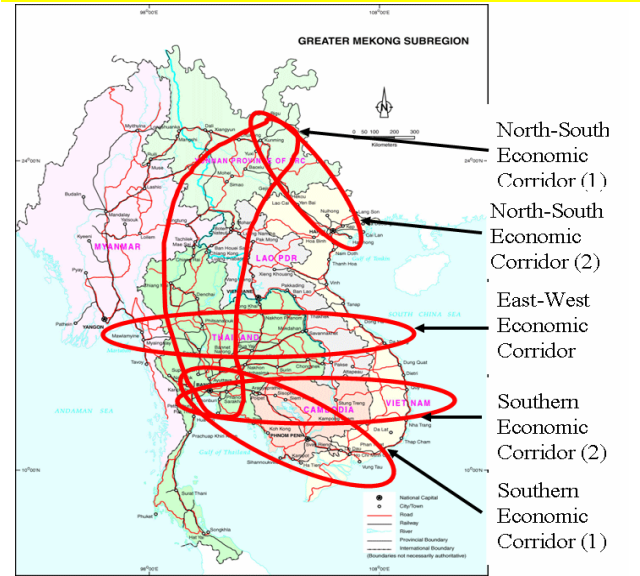

The following key components included in the project:-

- (1) The land required for the project will be provided gratis by Myanmar
- (2) Construction of port / inland water transport (IWT) terminal and related infrastructure facilities at Sittwe port
- (3) Development of Kaladan waterway from Sittwe to Paletwa (157 km)
- (4) Construction of an IWT / highway trans-shipment terminal and related facilities at Paletwa.
- (5) Construction of a highway from Paletwa to Myanmar-India border (248 Km)
- (6) Maintenance and management of the above facility components

Trial run for the India-Myanmar-Thailand (IMT) trilateral highway likely in December 2015 – supported by ADB

Expansive forest which covers half of total area of the country, exports 80% of world teak supply

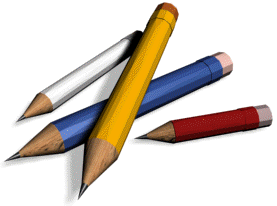
Fertile land for agriculture which amounts 19.3 million hectares arable land and out of these, over 6 million hectares have not yet been exploited

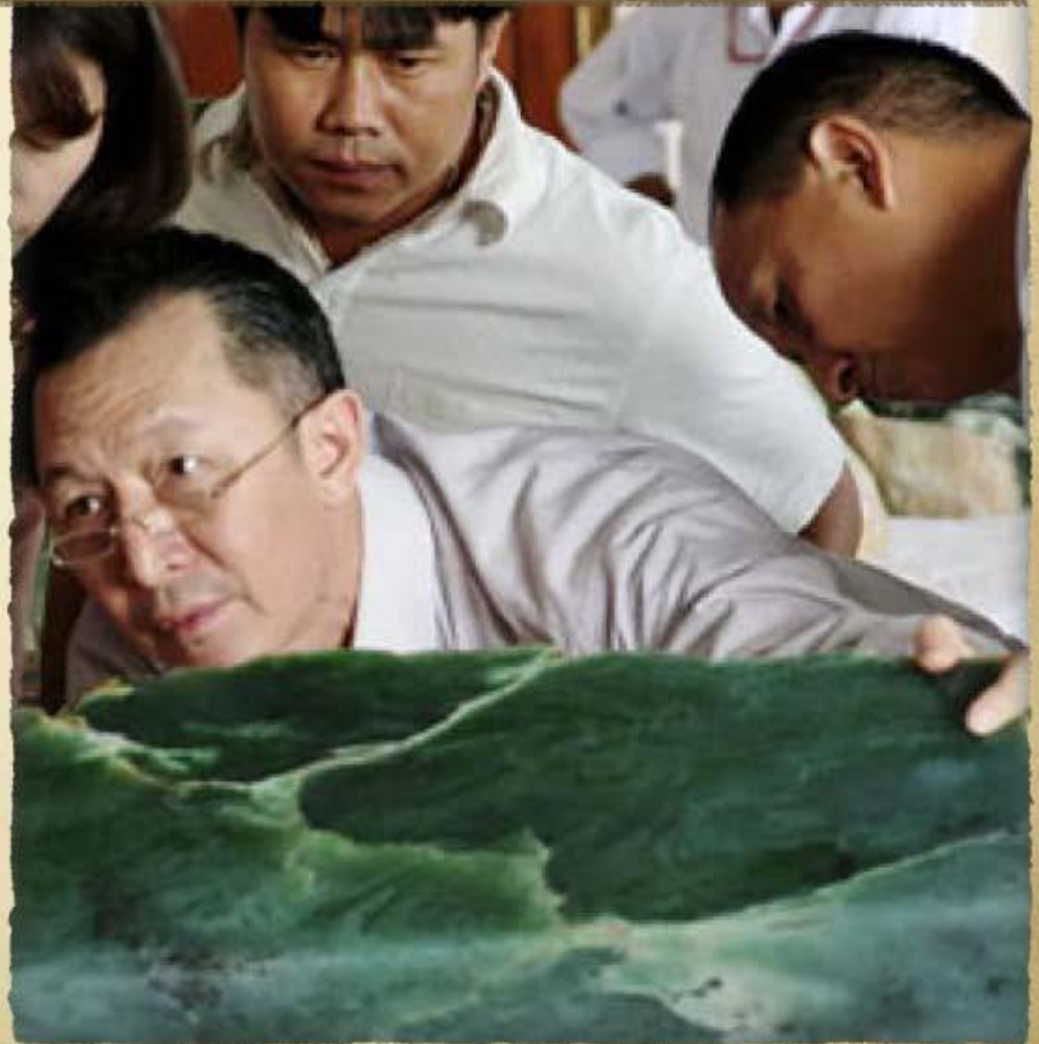

Submitting Proposal to MIC (Section 36)

Prohibited Investment

Business:

- the hazardous or poisonous wastes;
- technologies, medicines and instruments which are still being tested abroad or which have not obtained relevant approvals for use, planting except for the purpose of R&D;
- may affect the traditional culture and customs of the racial groups;
- may affect the public health
- may cause damage to the natural environment and ecosystem;
- manufactured goods that are prohibited in accordance with existing laws.





Restricted Investment (Notification 15/2017)

- Investment activities allowed to carry out *by State only*;
- Investment activities restricted *to foreign investors*;
- Investment activities allowed only in form of *joint venture* with a citizen owned entity or a citizen of Myanmar; and
- Investment activities permitted with the *recommendation of the relevant ministries*

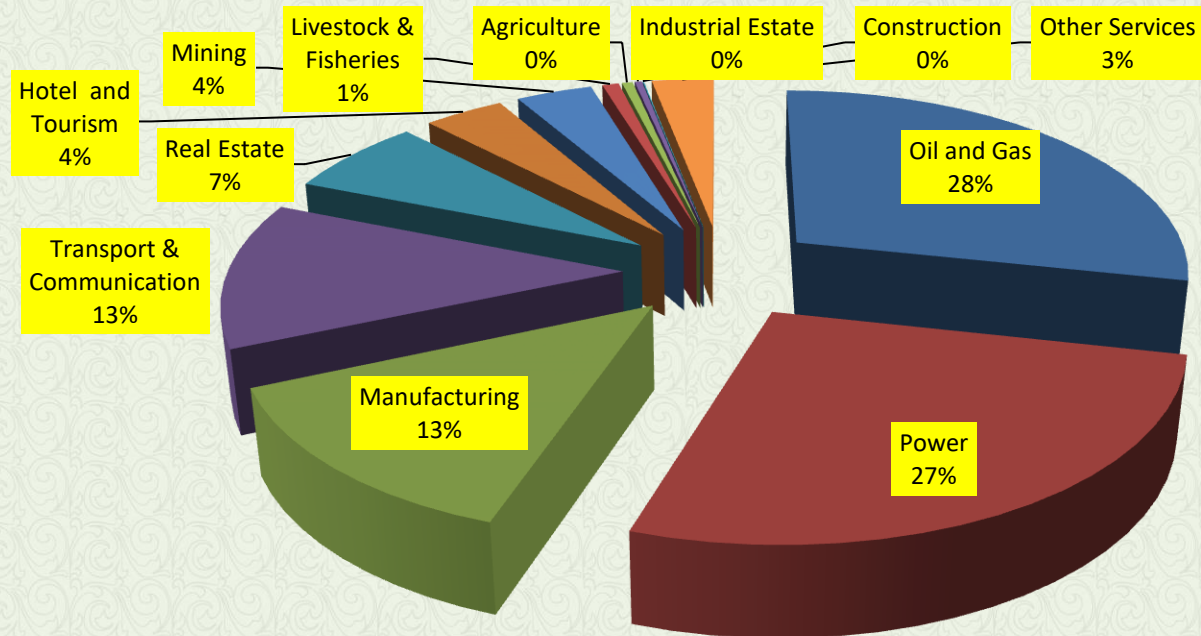

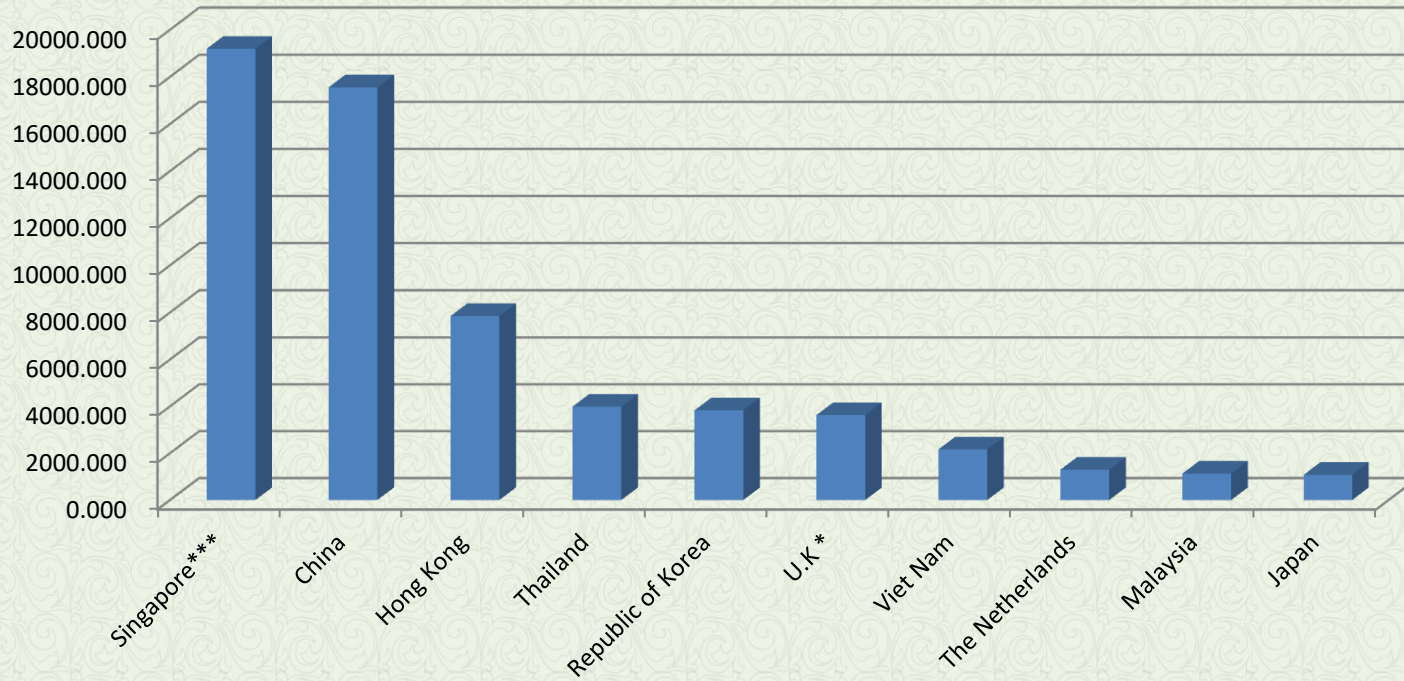
Foreign Investment in Myanmar
