



- 600 MILLION CLIENTS in radius of 2,000 km







AMONG WORLD LEADERS IN AUTOMATION

SLOVAKIA BELONGS TO <u>TOP 17</u> COUNTRIES WITH THE HIGHEST NUMBER OF INSTALLED ROBOTS IN THE MANUFACTURING INDUSTRIES PER 10,000 EMPLOYEES.

- There were **169 robots per 10,000 workers** in 2019, according to International Federation of Robotics.
- The number of robots used in Slovak companies has increased to 214% compared to 2015 figures.
- **Car and electrical engineering** industries remain to be leaders in implementing robotic devices.
- Robots are mostly implemented in handling, welding, painting, metal industry, logistics and as service robots.







ELECTRONICS & ELECTRICAL COMPONENTS INDUSTRY (EEC) IN SLOVAKIA KEY FIGURES




